O'Brien's E-Discovery Lab incorporates a number of innovations to reduce the burden of e-discovery. These include the development of proprietary scripts and custom fields that categorize large volumes of data in ways that even today's out-of-the-box software cannot do without advanced analytics, which may incur additional costs and time. This has resulted in drastically reduced review times, sometimes speeding up the process by as much as five-fold.

Perhaps just as innovative as the service itself is its cost model. While most third-party vendors charge for data processing and data hosting on a per-gigabyte scale, O'Brien's E-Discovery Lab takes a client-focused approach by charging an hourly rate for human labor — as opposed to the costs for time required to run automated processes. The end result is a rate that is much lower than the per-gigabyte model.

"I'm thankful that *The National Law Journal* recognized me as one of its 50 litigation trailblazers for 2016," O'Brien said. "I look forward to continuing to innovate as the intersection of law and technology evolves."
